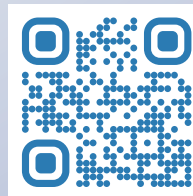

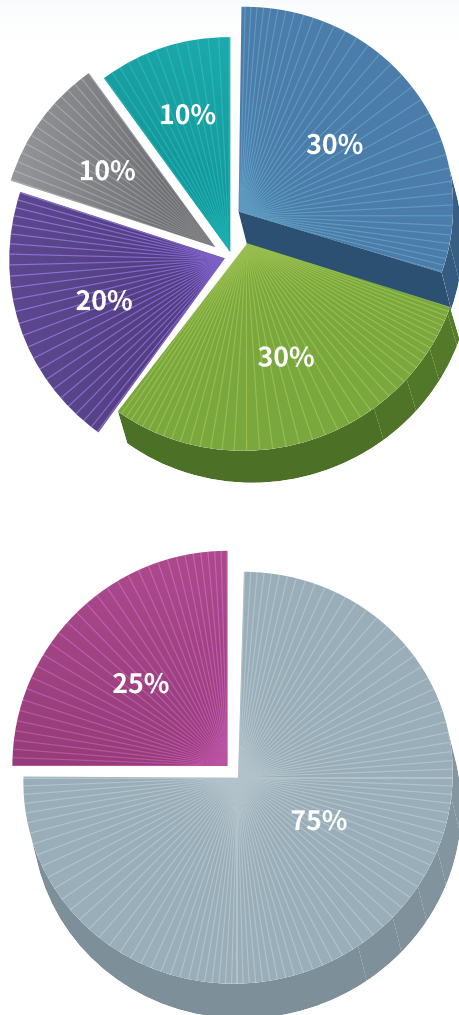

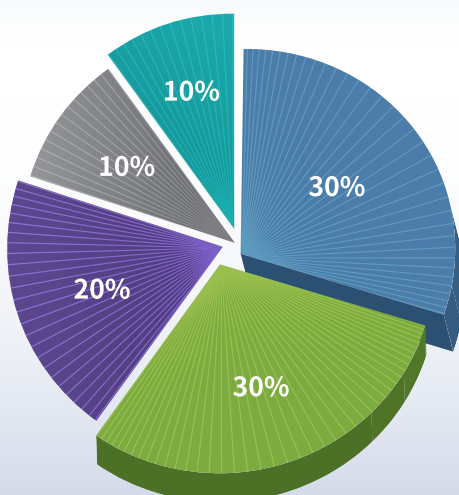

資格 Eligibility

項目 Project

- 本地項目地點及其建築工程(包括但不限於填海、工地平整、地基、上層建築、其他結構工程及機電工程等)的項目，但並不包括場地建立工作)均須位於香港境內，並於2021年6月30日之後施工。

Local Project shall be regarded as a project with its site located within Hong Kong and with its construction works (including but not limited to the reclamation, site formation, foundation, superstructure, other structural works, E&M works, etc., but excluding site establishment works) commenced on site after 30 June 2021.

- 在項目類別下，只有主申請人才可以提交申請，同一項目的共同申請人可納入同一申請內。

Only the main applicant can submit a Project for competition under Project Category. Co-applicants contributing to the same Project can be included in the same application.

- 每個機構在每次申請時只可提交一個項目，但可以提交多個申請。

Each organisation can submit one project per application only, but can submit more than one application.

- 在同一施工期內，地點或合同編號相同會被視為同一項目。

Projects with the same location or contract number within the same construction period are identified as the same project.

機構 Organisation

- 本地機構須為政府或法定機構，或根據《公司條例》在香港註冊。

Local Organisation shall be a Government or statutory organisation, or registered in Hong Kong under the Companies Ordinance.

- 中小企業是指聘用少於50名員工的公司。

Small and Medium Enterprise (SME) shall be a company with less than 50 employees.

- 每間機構只能申請一個次類別。

Each organisation can apply in one sub-category only.



遞交方式 Submission
